## **ROUNDS & RULES**

### **Round 1 Swimsuit Round**

Individual Introduction, contestant will do model walk and turns (we will go over this at the meeting). You will then be lined up as a group and the head judge will ask you to do ¼ turns for comparisons as a group.

**What to wear Men: Round 1**

Swimwear, board shorts, posing suit, your choice. Sandals must be worn.

### **Round 2 On stage live photo shoot**

Overview: This will be a live on stage photo shoot with a photographer taking pictures. You will be judged on the overall appearance, outfit, & professionalism that you have during the photo session. You will be judged on the poses you choose during the session. A prop will be on stage to aid in your photo shoot. Past shows we have used a square box to sit, stand or lean against. Time is 30-45 seconds.

**What to wear: Photo Shoot Round 2**

Your choice...Something that will add to the photo shoot. We are leaving this open so you can pick something that makes you look great during the shoot. All outfits must be general public accepted. Nothing sleazy or you will not be allowed on stage, use good taste.

## **EXAMPLES OF WHAT TO WEAR**

Men:

Jeans & Shirt , Coat with Tie, Coat no shirt.

We actually had a contestant come in Football pants, no shirt and shoulder pads, holding a football. The crowd loved it. Be creative

**Judging:** We are looking for a tone, fit body, which includes overall appearance, stage presence and emphasis on a " Fitness Cover Model " look.

**Tanning:** A spray tan is recommended
